LORD Fusor® 114LG/114SM Plastic Finishing Adhesive (Fast)

LORD Fusor[®] 114LG/114SM plastic finishing adhesive is designed for repair of surface imperfections, scratches and gouges on all plastic bumpers and body panels, including such plastics as PP, fiberglass, Metton[®], Telene[®], SMC, TEO, urethane and carbon fiber.

Note: Fusor 114LG/114SM plastic finishing adhesive is not to be used as a body filler.

Usage

Surface Preparation

- 1. Clean the damaged plastic with Fusor adhesion prep/ cleaner (Stock #703).
- 2. Dry plastics to be repaired and bring to room temperature.
- Sand the damaged area using 80-grit sandpaper. Make a gradual taper around the repair area to eliminate sharp edges. Blow away all dust. To prevent bond failure, use hand-sanding or operate DA sander at low rpms during surface preparation.

Note: This product does not require an adhesion promoter or surface modifier. This adhesive will not bond to melted plastics.

Product Preparation

- 1. Remove the cap and nose plug from the Fusor 114LG/114SM plastic finishing adhesive.
- 2. Insert the Fusor two-component adhesive cartridge into the dispensing gun (Stock #301).
- Squeeze a small amount of Fusor 114LG/114SM adhesive from each side of the cartridge. This will level the plungers and ensure that adhesive is coming out of both sides of the cartridge.
- 4. Attach the mixing tip and dispense a small amount of material, which is about the width and length of the mixer, to verify that the adhesive is evenly mixed and that the color is consistent.

Note: This product can be dispensed without a mixing tip. Dispense an equal amount of each component and hand mix by folding two components together. Do not whip; trapped air can cause pin holes in finished surface.

Application

- 1. Apply Fusor 114LG/114SM adhesive to the prepared area. Apply the adhesive slightly higher than the surface to allow for sanding.
- Allow adhesive to begin curing at room temperature, 70°F (21°C), for 10-15 minutes before sanding.
- 3. Use a DA sander with 180-grit sandpaper to rough and contour into the plastic. Block-sand and featheredge using 220- and 320-grit sandpaper.
- 4. Allow adhesive to cure for 60 minutes at 70°F (21°C) before final finishing.

 Prime and paint per manufacturer's recommendations.
Note: Do not use polyester body fillers over Fusor 114LG/114SM plastic finishing adhesive, as compatibility issues may result.
