3. COMPOSITION/INFORMATION ON INGREDIENTS

Acute: Possible irritation of the respiratory system can occur causing a variety of symptoms such as dryness of the throat, tightness of the chest, and shortness of breath. May cause lung damage. 4. FIRST AID MEASURES
